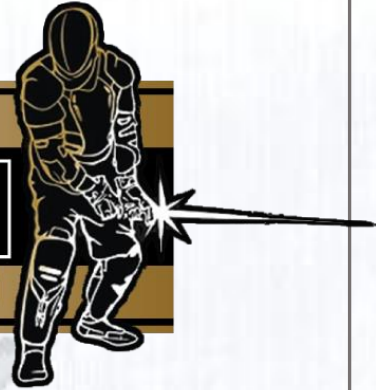

The parties to this release agreement are as follows

Full Legal Name _____ (Hereinafter referred to as "the Fighter")
AND **The Saber Legion, LLC.** (Hereinafter referred to as "TSL").

Whereas for valuable consideration hereby acknowledged as received, the Fighter grants TSL permission to photograph, film and/or sound record the Fighter and furthermore grants permission to use the resulting work ("the Work") according to the terms stated hereunder.

1. The Fighter acknowledges that since participation in TSL events is voluntary, the Fighter will receive no compensation unless otherwise noted by the event coordinator.
2. Any permission granted to TSL shall extend to its successors, legal representatives, licensees and assigns and shall be irrevocable and perpetual without any further or additional claim(s) by the Fighter.
3. Use of the Work shall be unrestricted as to location, quantity or frequency, may be for any purpose and in any medium, foreseen or unforeseen at this time, except where such use is in contravention of the law.
4. Permission is specifically granted for the Work to be edited, altered, distorted, used in whole or in part, in conjunction with other images, graphics, text and sound in any way and without restrictions.
5. Permission herein granted is absolute and final and shall not be subject to further inspection or approval by the Fighter at any stage in the use of the Work.
6. Use of the Work may be in conjunction with the Fighter's own or fictitious names.
7. TSL shall own all rights in the Work which shall accrue to the benefit of its successors, legal representatives and assigns.
8. The Fighter agrees that the provisions contained herein shall be binding upon the Fighter and his/her successors, legal representatives and assigns.
9. The Fighter warrants having read and understood this Fighter Release Agreement and warrants being of full legal age to enter into an agreement.
10. The Fighter hereby releases and shall hold harmless TSL and its successors, legal representatives, licensees and assigns from all claims or damages including but not limited to defamation or violation of right of privacy or publicity, resulting from or associated with the use of the Work.
11. This Agreement shall be construed, interpreted and governed in accordance with the laws and should any provision of this Agreement be judged by an appropriate court as invalid, it shall not affect any of the remaining provisions whatsoever.
